Directions from the North: Take I-95 S toward Miami. ~ Take the Linton Blvd exit, EXIT 51. ~ Turn left onto Linton Blvd. ~ Turn right onto S Federal Hwy/US-1 S/SE 6th Ave. ~ Turn right onto W Hidden Valley Blvd/NE 76th St. ~ Continue to follow NE 76th St. (NE 76th St is 0.1 miles past Bailey St.) ~ Enter next roundabout and take the 2nd exit onto E Country Club Blvd. ~ 7500 E COUNTRY CLUB BLVD is on the left.

Directions from the South: Take I-95 N toward W Palm Bch. ~ Merge onto Yamato Rd/SR-794 E via EXIT 48A. ~ Turn left onto NW 2nd Ave. Pass through 1 roundabout. ~ NW 2nd Ave becomes E Country Club Blvd. ~ 7500 E COUNTRY CLUB BLVD is on the right.
