Bingo was played and it was a joy seeing our children assisting the Intellectually Challenged Adults. Dance music provided. The participating parents, teenagers and children dancing with Intellectually Challenged Adults. CYO played as Elves and gave out gifts as each Intellectually Challenged Adult and child sit on Santa Claus's lap. CYO Members organize manage and implement this annual event. Council Members decorated the Parish Hall; furnished Pizzas; refreshments; and gifts. A Council Member's son acted as Santa Claus. CYO members served the food to each Intellectually Challenged Adult.

CYO/Intellectually Challenged/Parish Mardi Gras Party:

This year 150 people: 50+ Intellectually Challenged Adults; 100 parents, teenagers, elementary children, and pre-school children attended this event. CYO Members organize manage and implement this annual event. Council members decorated the Parish Hall; prepared beans and sausage, rice, garlic French bread and refreshments (many K of C members donated King Cakes. CYO members served the food to each Intellectually Challenged Adult. Council and CYO Members decorated an off terrain vehicle and wagon, drove the float with Mardi-Gras King and Queen.
